The Government of Malawi through Blantyre Water Board (BWB) has applied for financing from the World Bank towards the cost of the Malawi Water and Sanitation Project-1 (MWSP-1) and intends to apply part of the proceeds for consulting services.

The objective of the MWSP-1 is to increase access to improved water supply and sanitation services in Blantyre metropolitan area and to enhance the operational and financial efficiency of the Blantyre Water Board. Components 2 and 4 of the MWSP-1 is supporting priority sanitation investments and technical assistance and project management activities designed to support the project implementing unit and the incremental operating costs for project management. Some of the activities under these components shall include construction of public sanitation facilities and office upgrades at Project Implementation Unit (PIU) and Project Support Team (PST) in Blantyre City. Blantyre Water Board (BWB) would like to engage a consultant to prepare detailed engineering designs, tender documents and construction supervision of public sanitation facilities and office upgrades at (PIU) offices in Chileka and PST offices at Blantyre Wastewater Treatment Plant.

The consulting services ("the Services") include includes preparation of detailed engineering designs, bidding documents and construction supervision of public sanitation facilities and office upgrades at PIU offices in Chileka and PST offices at Blantyre Wastewater Treatment Plant. The assignment shall be conducted in two phases: Phase 1-preparation of detailed engineering design and tender documentation and Phase 2 – construction supervision.

The assignment shall be completed within a period of Twenty-Eight (28) calendar months. Phase 1 of the consultancy assignment is expected to be conducted over a period of four (4) months. Phase 2 shall be conducted over a period of Twenty-Four (24) calendar months which shall include a 12-months defects liability period. The assignment is expected to start in August 2023.

The Blantyre Water Board now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The shortlisting criteria are:

- (i) Core business area in Engineering consulting
- (ii) Relevant similar experience, which should specifically include the below:
 - Experience in carrying out feasibility of upgrading office structures/buildings
 - Experience in preparation of preliminary and detailed engineering designs, drawings and specifications for the office buildings/structures in line with relevant ISO and EDGE certified standards
 - Experience in preparation of comprehensive costing of the projects and bidding documents aligning to World Bank (IDA) requirements.
 - Experience in construction supervision of office structures/buildings
- (iii) Technical and managerial capability of the firm (Provide only the structure of the organization, general qualifications, and number of key staff. Do not provide CV of the staff). Key Experts will not be evaluated at the shortlisting stage.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" dated November 2020 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.

A Consultant will be selected in accordance with the Quality and Cost Based Selection method set out in the Procurement Regulations.
