The **Malawi Government** has received financing from the World Bank toward the cost of the Malawi Water and Sanitation Project – 1 (MWSP-1), and intends to apply part of the proceeds toward payments under the contract for **Supply and Delivery of Project Operation and Supervision Motor Vehicles**. “For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the World Bank’s Disbursement Guidelines for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.”

The bidding document in English may be purchased by interested Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **US\$100 or equivalent.** The method of **payment will be direct deposit into the account provided in 9 below.** The document will be sent by **airmail/email/local couriers.**
