The *Malawi Government* has received financing from the World Bank toward the cost of the Malawi Water and Sanitation Project – 1 (MWSP-1) and intends to apply part of the proceeds toward payments under the contract for **Construction of Smart Kiosks and Public Sanitation Facilities** as part of cholera response initiative for the project. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **18<sup>th</sup> January 2024 at 14.00 Hours Local Time**.
